At around 8.30am on 06/01/2018 I observed a barking dog run down onto the beach at Waipu Cove and chase any birds off the beach. He ran 300 to 400 metres up the beach to complete the task. Two more dogs appeared followed by their owner, Mike Fraser. The dogs ranged freely, at times called in. I said to him that dogs are meant to be under his control at all times and that they are not to chase birds or cause a nuisance. His response was in abusive terms. He then used a plastic bag to collect one of his dogs droppings and removed it from the beach. He then proceeded up the beach, one of his dogs defaecated on the water's edge before following on.

Immediately prior to the dogs arrival there had been a pair of oyster catchers, a couple of NZ dotterels and about 20 seagulls in the area in front of the boat ramp and more birds further up the beach. After the arrival of the dog there were no birds. As a frequent beach user I observe responsible dog owners walking their dogs along the beach interfering with neither anyone nor

bird life.

Please can you take action to stop this nuisance. Angus McCulloch

On Sunday the 10th of February John Henderson telephoned me to say that he had seen footage of me removing some signs referring to dogs on the beach. These signs were placed at the entrance to the public beach. I'm sure the reserve board is aware of the ongoing issues of harassment by Angus McCulloch towards dog walkers on the beach. I mistakenly saw this latest development as further escalation of conflict and tension between the local dog walking residents and Angus and removed the signs. There was no indication that these signs were endorsed by Waipu reserve board for example no logos or had been placed by the reserve board themselves and as such I believed I had the right to remove them.

However obviuously after the phone conversation with John that isn't the case. To be honest I found that conversation extremely threatening with John constantly repeating over and over again in a rather patronizing way that I had to review my position or he will press charges When I stated my position as above he just kept reiterating the same lines over and over again. What you might not be aware of is that I was a criminal lawyer in London and there is nothing in my behaviour today that could have successful charges placed against me. The burden of proof for example John ie Beyond all reasonable doubt and of course liability isn't strict with this sort of event. All that would be achieved is a community further divided by the actions of one person and now backed up by a board too frightened to stand up for all of the coves residents against a former board member. The only person considering their position therefore john should be you.

Moving forward your signs are undamaged and safe with me, if you want to remake them or take them back to put up yourselves passing on the cost to me then they can be collected from the cove (reasonable costs agreed by me first of course). Further i do feel being in the tourism hospitality business I look for ways to encourage visitors to Waipu & these signs carry a sense of animosity & do very little to make people feel welcome.

It is disappointing that the board has aligned itself with someone who bullies anyone who has different opinions to him and displayed homophobia behaviour towards Michael and I. We have contributed \$1000s of dollars towards the sand dune restoration in support of the board with never expecting anything in return.

I refer to your letter of 18 February 2019 regarding your concerns about the WCSLSC 90<sup>th</sup> celebration book. I am surprised by the nature of your complaint and believe it is an overreaction. That said, I have reviewed and taken on board your comments which I will address below.

Firstly, I would note that I cannot direct the WCSLSC to do anything. I authored the history, but the Club owns the book. The draft book was reviewed by a number of former campers/club members and senior club members with the Club's management committee approving it for publishing.

I also note on page 4 that "our history will be further reviewed, added to and enriched" and advise that some matters you have raised along with other corrections are being revised in the draft manuscript along with other corrections that will cover the next ten years for our 100<sup>th</sup> Celebration.

I do apologise for not fully recognising the interactions between the Club and the Board and staff as noted re the weed removal, Anton did a marvelous job, which is a consequence of the last two years of the Club's history being rushed to finalise it for the 90<sup>th</sup> Celebration and I was in the middle of a health issue. I do however note that on pages 117, 125, 137, 139, 146 & 149 our positive relationship, joint ventures and working collaboratively is acknowledged.

In response to other matters raised:

## Fact 1

As noted above this is being addressed in draft manuscript for the 100 years celebration.

## Fact 2

I disagree with your comments regarding "permanent sites". Littered through WCRB meeting minutes and camp manager reports from the early to late nineties are references to "Long Term Rental, Permanent Basis, Permanent Residents, Long Term Campers, Permanent Vans, Full Year Campers, Long Term Site holders, Permanent Sites and ratio's 60/40, 65/35 splits (permanent sites/ casual sites)" which reference to was discontinued following a DOC site visit Nov/ Dec 2000. In more recent times the Camp Rules of the time have evolved into the ASH agreement where I understand it was found that the Board was not authorized to make such decisions. I fully understand that the Commissioner now approves ASH agreements however in earlier times (much like what I understand occurs now) with casual campers over the Christmas break the permanent campers had certain rights of renewal, unless they chose to relinquish their site, were found to have seriously transgressed the camp rules or failed to pay fees. To categorically say *"there have never been permanent sites at Camp Waipu Cove"* is disingenuous given the history on the Permanent/Ash issue.

## Fact 3

Whilst I am fully aware of the Board's quantifying of fee increases in recent years, it was made clear by former campers/club members and permanent site holders that it became fiscally difficult for them (many on pensions/ fixed incomes) to remain as campers at a beach, despite having devoted much time and effort into its development.

Those campers/club members describe the fee increases as "enormous" (their quote) and it was noted that in the 7 year period from 2007/08 to 2014/15 annual fees increased from \$2096 pa to \$4000 pa an increase of 90.8%. Causal fees increased from \$28/ per couple to \$46/ couple and increase of 64.3%. This was against a CPI index 13.10% across this period.

Also noted to me for the 2009 year was an increase of reportedly 23% which was in acted with only 7 days' notice. Remembering this was in the middle of the Global Financial Crisis, many were on fixed incomes and trying to budget for this increase was stressful. Also, of note at this time (13 March 2009) in a DOC press release was that they had frozen their camp ground and hut fees; *noting; "In challenging times it is common sense to ensure that people can continue to enjoy the outdoors without worrying about increased charges"*.

Therefore, I do believe it is not unfair to use the camper's word of "enormous" when describing the increases. **Draconian and restrictive rules** 

Also noted by many permanent/ ASH campers spoken to (who used this term) was the continual erosion of freedom and use of the camp which I did not want to elaborate on, however I refer to your camp managers April 2008 newsletter where direct reference to "*not wishing to be draconian*" is noted around some issues of the time that were subsequently disproven.

Many noted in their description of draconian;

- 365 days use reduced to max 90 days (additional fees after 90 days) with a minimum of 30 days
- Full year use, with power being turned off over winter period, if staying over winter period power turned off on leaving to charging for power on top of annual site fees
- Washing & drying cloths were free now charged for
- Visitors to vacate the camp by 9:00pm
- Walking between sites with alcohol being prohibited
- Restricting the use of embankment after dark
- Overzealous security guards

While you may not agree with my response there have been many who have not been satisfied with the actions of previous Boards and claim its actions have had an effect on the Club and many older members – hence their story has been <u>briefly</u> told.

Also, of note is apart from this matter all feedback on the book has been positive and very supportive.

I freely acknowledge the efforts of the Board in ensuring that the camp is the show piece of DOC camping grounds and is being very well managed by the Board and your current manager Anton.

In no way is there any intent to offend.

Thank you for bringing this matter to my attention and providing me with the opportunity to address your concerns.

Perhaps better to meet with our Camp Managers during normal office hours?

Regarding the report below a bit more info. Roger says there was mention from your contractor for us to take photos of the dogs, their owners, and vehicle registrations.

We believe this is not reasonable and would put us into confrontational situations.

Our service expectation from WDC is for us to report problems to your contractor with an immediate response on site say within 2 hours.

What response time does your contract call for? Is it 24/7?

Our Board & Managers are ready to support your efforts. Please advise.

Hi John

Regarding the dog control issue on Sunday 10<sup>th</sup> at Waipu Cove, I called the 0800 932 463 at 9.46 am to request a dog control officer. I advised that there were 3 dogs running around the beach and the reserve, without any control at all and one was seen defecating on the beach by our Camp Manager. I requested a dog control officer as I thought it would be a timely opportunity to apprehend and advise dog owners who we know are repeat offenders. I was advised that someone would call me. At 10.15 a.m. Officer Kim Lyndsay called back and left a message that it was not her job and suggested I call back after after 9.00 a.m. Monday. I again called 0800 932 462 at 10.21 a.m. and spoke to 'Louise', who advised me I probably needed to give more detail, e.g. dog descriptions, registration numbers etc.

In relation to last Sunday, let me follow up with Armourguard and our afterhours contact centre on what precisely occurred here and get back to you. However, having read the below, I fear that requesting a "Dog Control Officer" might have confused the issue

and thus potentially resulted in the response that Roger claims to have received. Our contract with Armourguard provides for a 24/7 response by warranted enforcement officers, but after hours and on weekends these are 'generalist' enforcement officers, who are legally able to deal with all enforcement matters, including dogs, but are not necessarily dedicated 'dog control officers'. However, as I've stated, I will enquire and get back to you.

In relation to previous requests for photos or other evidence, this is often suggested by Armourguard staff to support claims of wrongdoing and provide (additional) evidence, as by the time an enforcement officer arrives (even where that arrival is within a short period of time), often the offending behaviour has stopped. Clearly, where your staff, associated parties or the general public are unable or unwilling to assist, that is fine and we will have to do without. However, please note that without such supporting evidence enforcement opportunities are often limited.

We are happy to meet with you and your camp managers, but as suggested a meeting during normal office hours would suit us better. Please let me have a few date/time suggestions to assist in our scheduling.

I fear your 'service response' expectations, outside the summer 'beach ban ' timeframes of between 20 December and 31 January annually, are totally unrealistic, as the contractual obligations of Armourguard (based upon cost limitations) for dog Bylaw breaches are a Priority 3 response and thus a response within one day and not necessarily within hours of such a Bylaw complaint having been received.

For example, a Priority 1 response would generally be a dog attack, which for your area generally stipulates a response time of 1 hour and 30 minutes. From this you can see that due to budgetary and contractual restrains an immediate response to dogs running loose on a beach or fouling a beach is just not possible under the current system.

I can appreciate that these limitations will not be to your satisfaction and we are fully aware of the calls and the need to increase our service levels and response times and we will shortly motivate for such improvements during upcoming contract renewal negotiations, however and ultimately this then becomes a decision our Councillors need to make, as it has substantial financial implications.

Having said that, I will try and ascertain whether within their current workload and contractual requirements, Armourguard would have capacity to send officers to Waipu Cove to do proactive monitoring and enforcement, as suggested and I'll get back to you on this.

Threatening behaviours towards us are quite common. We ask you to urgently bring this issue to your fellow Councillors because we believe there is a significant risk to public and animal (dogs & the protected wildlife reserve next door) safety at Waipu Cove Beach Reserve. To the board and others,

It was disappointing to get the notification from the board that annual site holders are to gone from Waipu cove camping in six years, not so much for me, as I will be in my seventies by then but for the young families who will not have the fun and friendship that we have had.

I feel the model of Annual site Holders (ASH) providing financial stability to a local board which has been able to fund outstanding facilities is forward thinking and one that should be replicated rather than removed.

That the board has been able to do all that they have done, developed th camp, built facilities, remediated sand dunes, saved birds, and still end up with \$670 000 in the bank shows how successful this model is.

That people wish to camp here and that the camp is only full for 15 days a years, like most camps in New Zealand, shows that no one is being prevented from camping because of ASH sites.

I would like to suggest to the board that it pushes back on the Doc demand and that it puts forward a proposal that keeps ASH sites at 25%, and start allowing young families the same opportunities we have had.

I would also like to suggest that fees are lowered substantially to increase the use of the camp, because with \$670000 in the bank despite building luxury cabins and expensive tennis courts, charges are too high for many families. Even in a lovely weekend in March there seem to be only about 10% of casual sites being used.

What the boards have achieved over the last thirty years is outstanding and should be celebrated and held up as a perfect example of user pays whilst also paying for public amenities. The Department of Conservation should be encouraging this model not dismissing it.

It is incomprehensible to the local community and to the ASH campers why it is being discarded.

We have posted signs advising the public to ring WDC dog control if they are concerned about dog behaviour because the NZ Reserves Act 1977 (see attached) is a legal requirement for us to do so.

Please note the draconian measures listed in Clause 14 - Dog Control - NZ Reserves Act 1977

Our only copy is hard to read so here is what it says...

#14. Dogs

(1) No person shall bring any dog into the reserve, or allow any dog in his custody or charge or under his control to be within the reserve, unless in either case the dog led on a leash or is otherwise properly secured to the satisfaction of some person authorised by the board.

(2) Any person authorised by the board (either generally or in any particular case) may seize and detain any dog found within the reserve not secured as aforesaid. If the owner of the dog is not known to the board or cannot reasonably be ascertained, it shall be committed to the local pound or to the SPCA.

No way are we going to determine what "*under control*" means and/or physically intervene although the Act tells us to do so. Our only action has been the signage.

We leave all monitoring & enforcement to WDC.

Meanwhile, we do understand your unhappiness with a local resident. However, we have no mandate or authority to pursue your complaints against that person.

Might we suggest you contact your local WDC Councillors Phil Halse & Shelley Deeming as the authorised persons to take your complaints to?

The Police can also deal with undue harassment against members of the public.

Lloyd you assert:

1. You are not Waipu Cove and what is becoming very clear to all of us YOU DONT REPRESENT US!

Absolutely correct. We are an unpaid volunteer Reserve Board appointed by DoC to manage the Campgrounds and Reserve adhering to the 1977 Reserves Act. Nothing else.

2. I and Marie and Maureen are all attending the meeting on Friday Re: the ASH and I feel it is about time that the community represented themselves on all matters relating to Waipu Cove. From now on we will be talking directly with DOC as a community by passing anything to do with the Waipu reserve board trust.

The Friday meeting has been requested by Annual Site Holders at the Camp and some local residents to meet with senior management from DoC to exclusively discuss the recent decision to terminate Annual Site Holder Agreements. This is a very emotive decision. Some ASH are driving up from Auckland straight after work to express their concerns between 7-8 pm. We only have one hour with DoC management. Don't think the meeting will respond well to anyone wanting to discuss other topics like dog management. Better to formally do that at our next AGM typically late August. Realise that is too long to wait so suggest you do take your concerns directly to DoC and WDC local councillors. Another option is to ask for speaking rights at our next local Board meeting on 29 April.

3. After all I like many I actually live here, I actually work here, I actually contribute to the area and it is actually my permanent home! My opinion like all of us that live here actually counts.

FACT: We have six volunteer Board Members who contribute to the area just like you do Lloyd. Four of us are very long term residents of the Cove and Waipu.

Our fifth member now lives at Waipu full time and I am at Langs Beach following 9 years at the Cove. All of us are locals! We are copying DoC to keep them in the picture and we want to note that all correspondence with the public and minutes of our Board Meetings are on our website for public access.

### Subject: ASH at Waipu Cove

It has been brought to our attention that DOC have withdrawn permission for the ASH at Waipu Cove Reserve effective 2024. Tony Bates and I (Glenys Hoffmann) have a property at Waipu Cove (16 years) and are disappointed that this withdrawal of permission has happened in our community without consultation of local residents/home owners and local businesses. We appreciate that there has been dispensation for Waipu Cove campground in that the ASH did not have to move structures as per other DOC sites -ie Ruakaka etc however we do not believe that the ASH process in place at present is unfair or problematic.

We chose to purchase in Waipu Cove 16 years ago, due to the community, stability and family friendly feel which in part is as a result of the camping ground. The friendships that have been developed, the support for the surf life saving club, the pool of nippers for the club have seen Waipu remain as a traditional "kiwi beach lifestyle". We consider ourselves fortunate to have this and be a part of this community.

The loss of the annual site holders could be seen as damaging the heart of this small community.

ASH outside of peak holiday season tend to provide some stability to local business, the surf club as they are more than peak season fair weather campers

Some time ago DOC commissioned a survey/review of Camping opportunities in NZ - excerpt below - and provides an informative and balanced view about camping and ASH.

It is interesting that the ASH have provided consternation for the odd local resident however there is no such consternation for the booking process that allows return camping bookings nor the amount of cabins and cost per night of these which are generally out of the range a lot of NZers that enjoy camping.

We would like to see a working group representing local property owners, local business, ASH, campers, DOC, Waipu cove reserve board to see how we can retain ASH so that all needs are met.

In Italics - the two excerpts for the DOC Review reflect how we feel about the Waipu Cove Camping ground.

There is an trend evident within camping NZ, that is a large number of NZ campers tend to return to the same location, indeed for many it is important that it is the same location, year after year for their holidays. These locations are often considered to be a second home, a place where the camper feels as strong a connection as in their real home. This connection is often initially driven by the physical attributes of the place (surrounding landscape, setting and good access to fishing areas ...) but develops into one that is driven by the social experience of being amongst a group of like minded campers. Many NZers grow up alongside each other at camping areas spending their summer holidays camping next to the same family. What develops is a real sense of community and shared ownership of thee camping areas. This is why many camping areas have allowed semi-permanent occupation of sites to occur as aw way of ensuring that these campers are able to access "their" site at their convenience.

69% of regular campers surveyed have a strong connection with a place and teen to return to the same camping area. Only 27% of all regular campers go to different sites.

It has been suggested that additional capacity over the peak period could be obtained by removing permanent or semi-pemanent occupation of camping sites. Despite the requirements contained int he Reserves Act 1977 applying to all camping areas located on public reserve land, the position taken in this review is that these are obviously people who greatly enjoy the activity of camping and the location so much that they are prepared to invest time and money to be able to stay in these places for longer periods. Even if they were unable to have such permanent or semi- permanent arrangements it can reasonably be assumed that they would still be camping at these, or similar locations over the peak period anyway. Consequently there would be no net effect on the available capacity at this time and no need to investigate further in the review.

HAPNZ continues to advocate that many their members permanent and semi-permanent camping provides and essential revenue stream that is independent of influences that may impact upon their main revenue earned from temporary campers. Revenue from these sites improves the resilience of many businesses allowing them to survive thee years when the revenue earned from campers over the peak period is less than anticipated.EG - poor weather changes in tourist patterns etc

We urge a serious review of the decision to remove ASH effective from 2024.

# Review of Camping Opportunities in NZ by DOC identified the following: (Note this is excerpts of the review)

- From a Campers perspective
- Social relationships

-The Environment

- -The activity simple, uncomplicated and no stress
- -The experience different to normal life

Focus groups of regular campers consistently identified the same benefits - predominantly:

-Being able to get outside and back to a simple, less complicated way of life

-Being able to s pend quality time with family - doing things they don't have chance to do at other times the year

-Socialising with friends and other campers - the camping experience, for most people was very much a social experience. Regular campers spoke about the camaraderie and sen of common purpose they felt with, and among other campers

-Feeling as if you belong to a community - being able to see the same people every year and getting to know them a bit better each time was viewed extremely positively, particularly for campers who return to the same site

-Not having it too easy - of many regular campers, camping is about having to work a little bit harder but feeling a stronger degree of satisfaction about their achievements

-Time out and down time, particularly from an urban lifestyle. Camping is about slowing down, not worrying whats happening around you and forgetting about the stress of a normal urban lifestyle

-Safe and healthy fun for children, and installing a different set of values - for many regular campers, the activity is about education children that there is much more to life than playstations and tv

-Appreciating the environment (plants and animals)- considered to be an extremely important part of camping with children - Affordable holidaying - most regular campers agreed that camping is still an affordable holiday option for a family who might otherwise not be able to take a holiday

NZers tend go camping in Summer School Holidays.

### Type of camping:

Basic Campground with some facilities such as long drop and water - 37.7% Campground with flushing toilets, running water and a cooking area but no power - 29% Total 66.7% Unpowered

Campground with flushing toilets,water and cooking area - powered - 16.2 % A holiday park including hot showers,entertainment area - 7.1% Total 23.3 Powered

Dependent on time of year /needs - 10.1 %

Regular campers aged 35 years or less - camp at basic facilities with no power - 44% vs 29% for aged over 35 years. Camping is being driven by the younger generation. However it is dependent on the number of times and length of stay.

There is an trend evident within camping NZ, that is a large number of NZ campers tend to return to the same location, indeed for many it is important that it is the same location, year after year for their holidays. These locations are often considered to be a second home, a place where the camper feels as strong a connection as in their real home. This connection is often initially driven by the physical attributes of the place (surrounding landscape, setting and good access to fishing areas ...) but develops into one that is driven by the social experience of being amongst a group of like minded campers. Many NZers grow up alongside each other at camping areas spending their summer holidays camping next to the same family. What develops is a real sense of community and shared ownership of thee camping areas. This is why many camping areas have allowed semi-permanent occupation of sites to occur as aw way of ensuring that these campers are able to access "their" site at their convenience.

69% of regular campers surveyed have a strong connection with a place and teen to return to the same camping area. Only 27% of all regular campers go to different sites.

It is obvious that people with such a strong connection to a place will be severely affected if they are unable to access that place. For these people the so of "their" camping area is not something that can simply be offset by moving to another camping area because the same physical and social characteristics are not likely to be replicated.

#### Permanent and semi permanent camping:

It has been suggested that additional capacity over the peak period could be obtained by removing permanent or semi-pemanent occupation of camping sites. Despite the requirements contained int he Reserves Act 1977 applying to all camping areas located on public reserve land, the position taken in this review is that these are obviously people who greatly enjoy the activity of camping and the location so much that they are prepared to invest time and money to be able to stay in these places for longer periods. Even if they were unable to have such permanent or semi- permanent arrangements it can reasonably be assumed that they would still be camping at these, or similar locations over the peak period anyway. Consequently there would be no net effect on the available capacity at this time and no need to investigate further in the review.

HAPNZ continues to advocate that many their members permanent and semi-permanent camping provides and essential revenue stream that is independent of influences that may impact upon their main revenue earned from temporary campers. Revenue from these sites improves the resilience of many businesses allowing them to survive thee years when the revenue earned from campers over the peak period is less than anticipated.EG - poor weather changes in tourist patterns etc HAPNZ also recognises that it is not in the interest of their members to have too many sites tied up in this way. This is because the revenue potential is far greater if the site is let on a nightly basis rather than subject to an annual rental. .....in this regard they believe that this issue is annotate is self regulating.

Evening Yvonne & Nicola.

Let me begin by sincerely saying that our Board does feel sorry for what has happened to ASH.

Speaking personally, If I was in your shoes, I too would be upset just as you and others are.

Having re-assured you about this, let me push back on a number of your assertions:

1. "Correct proceedures had not been followed regarding ASH sites and the Management Plan 2017.

\_\_\_\_\_

This statement is incorrect. We have followed all requirements of the Reserves Act under which we are appointed by DoC. We think what you heard was that DoC has not approved our latest Five Year Operating Plan because they want it to show that ASH site waivers are being dis-continued effective June 2025 and following notification from DOC that this is happening, we have amended our Plan. We believe you also heard DoC say they wanted more feedback from our Board back to submitters on our Plan with possible amendments to the Plan based on those submissions. This is being done.

\_\_\_\_\_

2. We find it hard to believe that not one Board Member picked up or realised that DoC had not made comment or submitted on this Plan. This statement is unfair and misleading because our Reserve Boards have been submitting Five Year Plans directly to DoC for about 30 years. We have not seen any evidence that DOC has ever formally submitted themselves. What they often do is to notify us of amendments they want to see....and we respond accordingly. Louisa was disappointed that DOC themselves did not submit this time. This is an internal DoC issue. DoC is our parent and we are not responsible for their actions.

3. In a decision of this magnitude we think we deserved way more consideration and respect than what has been "dished" out to us. Our Board did not make the decision to cease ASH site waivers. This came from DoC.

4. We are very disappointed with the result of recent meetings between the board and DoC and feel that the Board should have pushed back harder and demanded more from DoC.

DoC asked to meet with us end October 2018. They stated that termination of the ASH site waivers was a done deal and not negotiable. What was on offer for negotiation was the effective date of the policy change. DoC's internal preference was to end ASH site waivers two years after the current season. Our Board members pushed back hard on this timing and eventually we settled on five years notice after the current year. While we don't expect any thanks from ASH, we do want you to know these facts.

5. The board would be very aware that over the past 10 years there has been steady decrease in ASH and given the average age of the remaining ASH that this decrease will continue regardless that this past year it was apparently only one. This point should have been pushed home.

Our Board has made this point repeatedly to DoC. (See our letter dated 23 July 2018-below).

6. At the very least the Board should of consulted with ASH instead of accepting this situation and then not telling anyone..... Louisa Gritt explained at the recent meeting with ASH that our informal agreement regarding the five year notice period was not final until DoC ministerial approval and for our Board to formally accept the decision. Both parties agreed it was not proper to announce this decision until DoC issued a formal a letter to our Board. We wrote to all ASH immediately afterwards. 7. We expect our Board to be fighting for us.

What else would you expect us to have done? The ASH site waiver was not negotiable so we tried to make the best of the situation by pushing the effective date back by three extra years. Personally speaking, my only other option would have been to resign as Chair and Board Member in protest against the DoC decision.

However, I chose to lead our effort to secure more time for ASH to adjust to the policy decision.

Let me close with a reminder that our Board is 5 local unpaid volunteers trying to represent the best interests of all of our public stakeholders.

The recent ASH decision is not an easy one for us or our camp managers to manage.

All of us are doing our best to help everyone make the transition and we hope most ASH will come back after June 2025.

Please consider withdrawing your criticisms in the interests of fair play.

P.S. Not sure how many others have asked for speaking rights at our next Board meeting on 29 April? Asking our minutes secretary to let you know.

Good evening everyone, please find below Andrew Carvells notes regarding our meeting in 2011. You will note the drain was mechanically cleaned over 4 years ago, and prior to this it was cleaned in 2011. In his notes he refers to a 6 to 1 ratio of spraying to mechanical clean - from my understanding that amounts to 1 mechanical clean every 3 years. Goodness know when they last sprayed.

As I pointed out, everything that he requested the residents to undertake has been done - only the council has not honored their own rules.

Looking forward to hearing from you as to how we can get this maintenance program started again.

Marie, Jan, Evan et al

Thanks for the meeting yesterday morning.

There were a few issues touched on which I have summarized below.

1. As discussed we will prepare a plan around mechanical removal of material in the drain and spraying. We'll run this past you before starting the work

2. The Waipu Cove Reserve Board may have a suitable location for placement of the greenwaste material – Andy to confirm. We understand this is composted and used on the reserve grounds.

3. Our general philosophy going forward will be to spray the vegetation in the drain as a maintenance activity with periodic mechanical removal of larger vegetation. From discussion with NRC they use 6 occasions of spraying to 1 mechanical clean as a rule of thumb which would appear to be appropriate in this situation.

4. It was discussed that WDC does not maintain the drain to solely improve appearance. It was accepted that it is a very slow moving waterway that would grow algae and potentially harbor mosquitoes at times.

5. Jan agreed to remove the small footbridge at the rear of her property that spans the drain. This should be done as soon as possible.

6. The person who has vegetation along the drain is to remove the vegetation or relocate his fence so that the vegetation can't go into the drain. As a note the drain verge is not to be used as a site for depositing waste vegetation or rubbish. When the stream floods the vegetation is carried away and can block culvert and/or bridge underpasses .This practice is in breach of the WDC Stormwater Bylaw:

6 Obstructions to stormwater systems

6.1 Prohibited activities

No person shall:

a Obstruct any facet of any public or private stormwater system in a manner that is likely to cause nuisance;

b Erect any structure or stopbank, grow any vegetation, deposit any rubbish or other debris, or carry out any activity in a place or manner that is likely to cause nuisance to a public stormwater system during a storm event or without the prior permission of Council; or

c Obstruct any overland flow paths or flood plains with any material or structures such as buildings, fences, retaining walls and rock gardens without the prior permission of Council.

7. The reserve board is to remove the tree near the storm water culvert and near the wastewater pump station.

8. Consideration is to be given to the planting of trees to shade the drain. A preference should be given to evergreen trees that do not drop material in the drain. If possible they should be planted on the northern side of the drain to maximize shade of the water, though should not hinder the flow of water or access for cleaning.

9. There are a number of large trees next to the drain, in particular the pine tree on Marie's place. The large pine will need to be removed at some stage before it threatens the operation of the drain. Homeowners are encouraged to remove young trees close to or within the drain as soon as possible while they are small.

10. The effect of downstream water level on the risk of flooding was discussed. If the downstream level is high due to tide or high flows in the Waipu River there is little drainage from Waipu Cove and the properties in the flood hazard area will likely be affected. Drain maintenance will not address this risk.

11. We discussed the issue that flooding is expected to get worse over time with sea level rise, change in frequency of storm events and potential for the old river section of the drainage system filling in. A long term solution may be to look at a stop bank and pumping option or raising properties/dwellings or other solutions. It is suggested residents and the reserve board maintain contact with Council over long term planning issues.

12. As discussed Council's Long Term Plan is out for consultation end of March/April. As discussed residents may wish to lodge submissions on drainage issues for Councils consideration.

I trust this captures the main points of our meeting.

Regarding the proposal in the WCRB Minutes 21st October 2019 for the construction of a BMX Track and MiniPutt Course. We believe that the money could be much better spent on the following -

1. Repairing the watertight issues with the camp house/office.

We are budgeting for a big re-development of the Camp entrance/roading/drainage and replacement of existing buildings. We expect to commence in 2022.

2. Weatherproofing the BBQ area at the northern end block. This area is extremely well used over the summer period but cannot be used during wet/windy weather.

This area has a water tight roof over it and the sides are open aired because campers say they like the open air feeling. It was upgraded with a new BBQ and extended area 3 years ago.

3. Replacing the cisterns in the Northern Ablutions block These cisterns regularly do not flush, and at the same time are continually running and wasting a huge amount of water. We have mentioned this problem numerous times to office staff. The manufacturer of the cisterns has carried out repairs and we believe they are working properly.

We understand that neither Miranda or Rotorua Top 10 Camps do not have the huge natural playground - the beach, that we are fortunate to have at Waipu Cove.

We are wanting to divert our younger "kids on bikes" away from using the internal Camp roads. Adult campers have raised this as a safety issue.

The proposed bike track and additional recreational facilities are included in the our 5 Year Management plan.

The area will be fenced on the sea side to minimise effects on nearby ASH sites. Camp rules say no bikes after 9pm and before 9 am; this will apply to the track & mini golf.

The track is being designed for younger camper use, not teenagers. We anticipate that parents will volunteer to supervise the area. We believe that there is already enough facilities and activities for both children and adults to enjoy at Camp Waipu Cove.

Our benchmarking against other camping grounds, customer feedback and industry professionals indicates we need more ammenities in the camp.

We appreciate your concerns especially due to your site's location and you have our assurance that as we create this new facility we will do what we can to minimise the effects on you and other ASH.

For clarity I have added my thoughts to your text.

We think you will agree the new board is a significant upgrade from the old manky one.

Significant no doubt refers to the cost. My concern is with the reduced size, I had assumed that a replacement would have been able to do the same job when the only issue was a perceived aesthetic one. (The appearance could have been improved with paint and regular cleaning – I have cleaned the noticeboard and the signs in the day area several times when they have started to turn green)

The noticeboard in the grass area to the right of the boat ramp could do with some TLC.

It is smaller to limit the postings to quality not quantity.

There has been very little of either for several years. As a matter of courtesy visitors deserve to be able to access information that would add to the enjoyment and appreciation of the reserve. The signs advertising the camp have got bigger more prominent no doubt to improve their effectiveness. By reducing the size of the noticeboard does it mean you wish to be less effective in communicating with the visiting public.

We also provide info listings on our Camp website because more stakeholders are using this method to keep informed. I have periodically reviewed the Camp website and have noticed few notifications of upcoming events. The arrival of cars, equipment and people on the day of an event is the usual notification.

We are holding the dog signage in reserve because at present the problem has mostly gone away. We are working on new proactive "educational" signage showcasing our sea birds to try to motivate dog owners to respect our Reserve.

Fully support and would encourage you to have it in place before the influx of holiday visitors – maybe a good time to do some trials to see which achieve the best results.

This approach by Kiwi Coast Trust is achieving positive dog owner behaviours in the Far North. Will keep everyone posted on our progress. Of course, we continue to pressure WDC to increase their bylaw enforcement at the Cove. *The most effective enforcement comes from other beach users if there are clear notices of what is reasonable and considerate behaviour.* Regards Angus
