Revenue:

Revenue down for the month \$2,824 which is pretty good considering Easter was in April last year and the SH1 road closure was still in place. \$26,597 is covid write off's where credits have expired so have been absorbed. YTD revenue is at \$1,926,633 which is up \$263,668 on same time last year. Net surplus is up \$263,538 on same time last year and we are forecasting a net surplus before depreciation of \$851,616 at year end.

Expenses

Expenses well controlled and down \$11,137 on month last year, annual leave \$12,190 with a lot of staff taking A/L in April and also having what's owed paid out to them.
