Request received from Waipu Cycleway group regarding a donation for the final stretch of the cycleway from McLean Road to the Waipu Cemetery before handing over the remaining stretch for completion to the WDC.

MANAGER'S REPORT AUGUST 2024

It's been a couple of months since our last report and spring is almost upon us. Overall winter this year has treated us far better, with much less rain and more sunny (albeit chilly) weather. Plenty has been happening over winter to keep us busy, and we are already planning for our busy season, with Labour weekend only 8 weeks away.

In late June, several Reserve Board members attended the Junction magazine awards on our behalf, due to a clash with a pre-arranged staff function. Camp Waipu Cove were lucky enough to be voted the winner of their "Entertainment and Tourism — North" award. This was determined by votes from the public. We were finalists in this award in 2023, so it was nice to win it this year.

We've had a few staff (including us) take some annual leave over this quieter period. We are so busy over the summer months that the bulk of time off always needs be taken in our off season.

Work on the 2022 and 2023 FY audits has continued. We and Elevate CA have been busy with Audit NZ requests, and these are now very close to being finalised. We will commence work on the 2024 FY audit shortly. This will bring us up to date in the audit cycle.

We met with WDC and the drain surveyor in late July to discuss and analyse the survey results and try to determine the best way forward to address community concerns regarding the flooding issues in the Cove. This discussion is ongoing, with WDC looking to provide an update to concerned residents in due course.

The culvert behind the tennis court was cleared out in July and now looks a lot tidier. This, along with the previous digging of a culvert to run behind sites 6-15 in June, should make some small difference to our drainage issues.

Steven Chambers of Stufkins and Chambers Architects came to site in early August and had a walk around the camp. We will be working with him to redesign the layout of the camp post ASH, who will be vacating by the 30th of June 2025. He indicated to us that we can easily add approximately 50 additional sites, which will increase our capacity substantially. We are due to receive his preliminary drawings before the end of August, and he will be able to give us a ballpark figure as to costs for further plans.

This month we undertook our annual health and safety audit with our Employsure H& S advisor. She noted several areas of improvement over the last 12 months and was overall very happy with our systems and processes. We are now working on implementing their Bright Safe on the go H & S app to make our pre-start checks and site inspections a smoother process.

Alan Neale has been painting some of our cabins over the last month, inside and outside. He will be finished by the end of August. He is currently painting the inside of the all-weather room, which was due a touch up.

This August we have begun our annual "Wellness month" with providing wellness packs to the staff. They also have the option of a paid walking break or to try yoga or circuit classes at The Shred on South Road. Everyone is keen to get fit and healthy for the busy season. We have also recently gone onboard with EAP Services, as part of our efforts to support staff wellness.

We recently attended the HAPNZ conference in Wellington, where we were a finalist once again in the industry's premier award the "Spirit of Hospitality". This award scrapes the web for any and all reviews left by customers, and ranks all holiday parks in New Zealand according to these scores. This time we were not the winners, but it was exciting to be a finalist, nonetheless. There was less than a percentage separating the five finalists, so it was a close competition. We were also asked by the Chief Executive of HAPNZ, Fergus Brown, to give a presentation to our industry peers outlining our "strategies for success" and "sustainability initiatives". The presentation went well, and we were approached afterwards by other parks wanting information, especially regarding our sustainability initiatives. It was fantastic exposure for Camp Waipu Cove to present in front of over 200 holidays park owners and manager's from throughout New Zealand.
